## Motion to approve April 2015 meeting minutes: 1 A DeSantis, 2 C Fillinger: APPROVED

President's report:

- Concern addressed from homeowner via email regarding installation of speed table on Oak Farm Drive at entrance to walking paths
  - Per Dave Brown, VDoT has 5 bullet points that they need satisfied in order to qualify for a speed table. Suggests posting on website and facebook page to look for someone to champion obtaining this information
  - Will advise homeowner requesting speed table and see if he'd like to spearhead this
- Ad-hoc committee for basketball court submitted an initial email outlining short term and long term suggestions to solve non-resident problem on courts, discussion notes below

Brian provided them everything necessary to apply for the Main Break Relief they offer. They have since reduced the bill by \$7,8824.83. We still owe \$5,096.71.

- Resident has requested a fall cleanup/fall yard sale date.
- Look into having a community shred date as well.
- Ad-Hoc Committee on non-resident basketball court use
  - Short term recommendations:
    - Enroll in Trespassing Enforcement Program
    - Revitalize Neighborhood Watch Val Silva-Horan has volunteered to head this up
      - Bring "Neighborhood Night Out" event to community and team up with social committee to make this a large community event
    - Use pool passes as resident identification
    - Rename park on Google Maps or request removal of tag
    - Talk to parents of kids that are inviting friends to play on courts but not chaperoning them
  - Long Term recommendations:
    - PWC/VDoT Traffic Calming Plan
    - Identify peak time when an off-duty police officer would be used to mitigate speeding, court use, etc.
    - Removal of basketball court if no ramification steps have proven successful
